In case of a full converter **Micro-generator** (eg wind) the primary source and the prime mover **Inverter**/rectifier may be replaced by a **DC** source.

In case of a DFIG **Micro-generator** the mechanical drive system may be replaced by a test bench motor.










#### Test 6 RoCoF withstand


